Council Minutes January 17, 2017**

The meeting was called to order at 6:30PM by president, Judy Conrad.

**New Business**

**Personnel Committee:** Members presented to Council to be considered for the Personnel Committee are: Kevin Dagliano, Ginny Doarnberger, Nancy Krueger, and Kathy King. **A motion was made, seconded, and approved to extend an invitation to Ginny Doarnberger and Kathy King join the Personnel Committee to serve a three-year term, expiring December 31, 2019.**

Members of the Finance Committee will include: Ed Drawbaugh, chairperson; Jena Staley, Judy Conrad, Bill Griemsmann, Inge Dudda.

**A motion was made, seconded, and approved to appoint Inge Dudda as Treasurer for 2017.**

Social Ministry and support individuals will begin research on starting a 501(c)(3) to ensure the continuity of the outreach ministry of the food bank after the support from the Hershey Foundation is exhausted. This would allow for grants and other financial support and the opportunity to work with other churches and organizations with common interests.

**A motion was made, seconded, and approved for council to begin to investigate creating a 501(c)(3) to fund the food bank.** Colleen Gildee, Inge Dudda, and Pastor Bettye will present information at the February meeting.

Quarterly Congregational Meetings suggested dates are March 26, June 25, September 24, November 19 (annual congregational meeting) in conjunction with unity services. Dates may be adjusted. Lauren Rowe, as liaison, will request unity services for these dates at the next Worship & Music meeting – starting time of 9am.

**President's Report**

Watson Rasey has resigned his position on council due to health reasons. **A motion was made, seconded, and approved to invite Craig Fentress to assume the open Council position vacated by Watson Rasey.** Craig has a heart leading him to offer his time for this position and also brings skillsets in technology and non-profits. He will be installed at a later date determined by Craig and Pastor Bettye.

A thank you to Pastor Bettye for hosting council dinner last week in preparation for the retreat.

A reminder that Shrove Tuesday is February 28<sup>th</sup>. Basket Raffle, instead of being held on Easter Sunday, will be held on Shrove Tuesday. The request is being made that teams, staff, and council/executive team be responsible for a basket. **A motion was made, seconded, and passed that proceeds will go to the food bank.**

Wednesday Lenten meals and worship will begin soon. Sign-ups will be available for food for the attendees of the study and worship.

Seder meal has been requested for Maundy Thursday, April 13. Worship and Music Committee will be asked to assist in this event.

A request is made to Personnel and Property teams to review the sexton job description and title to ensure that it encompasses all of the work actually being done.

A concern was expressed that the Boy Scout troop chartered through Trinity does not provide many services to the church. This item will be added to the list of 'elephants' at Saturday's retreat/planning session. Hunt Hardinge will be asked to attend a council meeting to discuss these issues.

**Retreat on 1/21 (rescheduled from 1/14) will take place in Memorial Hall. This is a change in location. The Buddy Prom shopping day will be happening in Fellowship Hall that day.**

### **Staff Reports**

A congregant donated shares directly to the endowment fund for the purpose of paying down the boiler principal. Amount is approximately \$7,000. **A motion was made, seconded, and passed for Inge Dudda to request the donated funds from RBC and make an additional principal payment on the boiler loan.**

**A motion was made, seconded, and passed to change Trinity's check signers from Ginny Doarnberger and Jean Price to Inge Dudda and Judy Conrad.**

- Contract brick work from Sweeney has been completed. They will be returning to seal the brick and remove the lift at a later date.
- The A/C removed from near the Randolph Street entrance was old and in disrepair and will need replacement.

- Apple Valley Waste has provided a quote for dumpster services which is significantly lower than our current provider. The committee will be considering this change.
- Candle concern expressed in the Property Committee is passed along to the Music and Worship Committee.
